

TERMS AND CONDITIONS

REGISTRATION CONDITIONS

Cancellation Statement: Cancellations received in writing at the Congress Office by Friday 19 July 2019 will be accepted and all fees refunded less an administrative fee of AUD \$100. Cancellations received after this date cannot be accepted and will not be refunded.

Transfer of registration: Transfer of your registration to another person is acceptable. The full name and details of the person that will replace you must be advised in writing to the Congress Office prior to the Congress. Non-attendance: No refunds will be made for non-attendance at the Congress.

NOTE: To qualify for early bird registration, registration fees must be paid in full by 1 July 2019. Registration fees received after this date will revert back to the standard congress applicable rate. Registration fees are based on date of payment receipt, not the date of receipt of registration form.

After 31 July midnight AEST, only payment made by credit card will be accepted.

ACCOMMODATION CONDITIONS

Rooms are being held by the Congress organisers on behalf of the delegates until Friday 19 July 2019.

Booking: To secure a hotel accommodation booking, the hotels require credit card details, which must accompany the registration form.

Regardless of method of payment for Congress, you must provide credit card details which will be forwarded to the hotel at 30 days prior to the Congress. The Congress organisers will forward your contact details, reservation and credit card details to the hotels and they may charge the one night's deposit at 30 days prior to the Congress start or at check in.

The rates per room per night are inclusive of Goods and Services Tax (GST), which is charged by the hotel on checkout. The hotels may charge you a surcharge for credit card transaction fees.

Payment: The hotel may charge the one night's deposit at 30 days prior to the Congress start or at check in. Delegates must settle the balance of their account and any incidentals upon check out. The deposit for the first night is non-refundable if the reservation is cancelled on or after Thursday 19 July 2018, or if you do not arrive on the date specified in your booking.

NOTE: Any changes made on or after 19 July, 2019, will incur a 100% cancellation fee. This includes any reductions to total nights booked. No shows will be charged at the full accommodation rate for the duration of the booking. That is, all nights for all rooms booked will be charged directly by the hotel to the credit card provided at the full accommodation rate Early/late arrival: Please advise the congress office of any early or late arrives.

NOTE: Hotel's T & C's do not apply for any accommodation booked through the congress website.
